

Waiver of Liability and Hold Harmless Release Related to COVID-19 for Participation in Global Enrichment

The student named below has requested to participate in Global Enrichment after school program that include, but are not limited to, meetings, special events, engaging in projects, and entering and remaining in premises leased or owned by Global Enrichment at the time when the extracurricular activity is being held.

In consideration for being permitted to participate in Global Enrichment, I hereby acknowledge, affirm and agree to the following:

- The novel coronavirus ("COVID-19"), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. While rules, guidance, and personal discipline may reduce this risk, the risk of serious illness and death does exist.
- I acknowledge that I am aware that by participating in Global Enrichment that there is a risk of being exposed to COVID-19, and/or any mutation or variation thereof. I am also aware that such an exposure can occur either directly or indirectly whether or not a mask and/or gloves are worn and that Global Enrichment cannot guarantee that by participating in Global Enrichment programs that there will be no exposure to COVID-19. Global Enrichment cannot completely mitigate the transfer of communicable diseases like COVID-19 especially when individuals are involved in Global Enrichment programs. Participation in Global Enrichment includes possible exposure to and illness, injury, or death from infectious diseases including COVID-19.
- I understand that my child's participation in Global Enrichment is not required. I have independently evaluated and reviewed the risks of my child being exposed to or infected by COVID-19 and have decided to allow my child to participate in the Global Enrichment program with full knowledge and acceptance of the risks.
- In consideration for providing my child the opportunity to participate in Global Enrichment programs and any related transportation to and from Global Enrichment, both my child and I voluntarily agree to waive and discharge any and all claims against Global Enrichment, their officers, agents, employees, volunteers, and representatives and release them from liability for any exposure to or illness or injury from an infectious disease including COVID-19, including claims for any negligent actions of Global Enrichment, their officers, agents, employees, volunteers, and representatives to the fullest extent allowed by law, for myself, my spouse, children, our estates, our heirs, our administrators, our executors, our assignees, and our successors.
- I also agree to release, exonerate, discharge and hold harmless Global Enrichment, their officers, agents, employees, volunteers, and representatives from all liability, claims, causes of action, or demands, including attorney fees, fines, fees, or other costs (e.g. medical costs) arising out of any exposure to or illness or injury from an infectious disease including COVID-19, which may result from or in connection with my child's participation in Global Enrichment.

- I further certify and represent that I have the legal authority to waive, discharge, release, and hold harmless the released parties on behalf of myself and the student named below.
- I certify that I have read this document in its entirety and fully understand its contents. The student named below and I freely and voluntarily assume all risks of such hazards and notwithstanding such, release Global Enrichment, their officers, agents, employees, volunteers, and representatives from all liability for any loss regardless of cause, and claims arising from the student's participation in Global Enrichment.
